WHY DID I GET THIS NOTICE?

You have received this Notice because we believe that you are a class member who obtained money from a settlement in a lawsuit titled *George v. Retail Merchandising Solutions, Inc.*, in the Alameda County Superior Court, Case No. RG16828194 (the "Lawsuit"). This Notice is being sent to you by the order of the Alameda County Superior Court regarding a change to the class period, which initially was defined as August 22, 2012, through May 22, 2018.

The Parties to this case have recently become aware of an error as to the class period, namely, that the class period should be August 22, 2012, through April 10, 2017. The Parties have asked the Court to amend the class period to reflect these updated dates, and the Court has approved that change. As part of its approval, the Court has directed the Parties to issue this notice to you.

The amended class period does not affect any payment you have received, and there is nothing you are required to do.

At that time the Parties agreed on the settlement and provided notice to the class members, the class population was believed to only include approximately 3,700 individuals. Subsequently, the Parties became aware that approximately 400 individuals were inadvertently excluded, and the Parties also learned the data used to reach the settlement included only individuals who had worked at RMSI prior to April 10, 2017, and that the initial class population also only included individuals who worked at RMSI prior to April 10, 2017.

Now, using the same formula applied to the 3,700 individuals initially a part of this settlement, RMSI has agreed to pay approximately \$33,000 to the 409 incorrectly excluded class members, and Court has approved this additional payment. This payment to the 409 other class members does not affect any money you received, and it does not entitle you to any more money under the settlement.

You were identified as one of the roughly 3,700 individuals, and you then were issued a portion of the settlement fund. The exact amount you received was an overpayment of what you were actually due; however, RMSI will not seek to recover that amount from you. As part of this process, you released legal claims through May 22, 2018. However, because the Parties relied on data and a list of class members only up to April 10, 2017, the Court also has ordered that the period of time covered by the settlement shall extend only up to and including April 10, 2017.

The purpose of this notice is to advise you that the amended class period with a last day of April 10, 2017, means that you have now released the claims brought in the lawsuit only through April 10, 2017 – language and terms of the release have not changed in any way, only the date. Accordingly, you may have legal claims against RMSI from April 10, 2017, to the present.

This Notice is only a summary of the modifications made to the settlement.
