1 The above-entitled action (“Action”) was commenced on October 23, 2018, when Plaintiff  
2 John Laqui (“Plaintiff”) filed a Class Action Complaint for Damages and Enforcement Under the  
3 Private Attorneys General Act, Cal Labor Code § 2698, *Et Seq.*

4 On February 17, 2021, the Court entered the Final Approval Order and Judgment, thereby  
5 granting final approval of the settlement of the Action reached by Plaintiff and Defendants  
6 Hollingsworth Logistics Group (“Defendants”) in accordance with Joint Stipulation of Class Action  
7 and PAGA Settlement and Release (collectively, “Settlement,” “Agreement,” or “Settlement  
8 Agreement”), which, together with the exhibits annexed thereto, set forth the terms and conditions for  
9 settlement of the Action.

10 On October 13, 2021, the Declaration of Kevin Lee on Behalf of Settlement Administrator  
11 Regarding Final Accounting (“Disbursement Declaration”) was submitted for filing in the Action.

12 On March 17, 2021, the Settlement Administrator issued Individual Settlement Payment  
13 checks to four hundred thirteen (413) Settlement Class Members. Based on the Disbursement  
14 Declaration, the deadline for Settlement Class Members to cash or negotiate their Settlement Payment  
15 checks expired on September 13, 2021, which was one hundred and eighty (180) calendar days from  
16 the date Individual Settlement Payment checks were issued. As of the date of the Disbursement  
17 Declaration, there are eighty-four (84) Individual Settlement Payment checks that were issued on  
18 March 17, 2021, totaling \$22,279.50, that have not been cashed.

19 Pursuant to the Settlement Agreement, the value of any checks uncashed more than one  
20 hundred eighty (180) calendar days after issuance shall be distributed to Legal Aid at Work.  
21 Accordingly, the Qualified Settlement Fund established was interest-bearing and shall be paid for the  
22 benefit of Legal Aid at Work. As of the date of the Disbursement Declaration, the amount of interest  
23 that has accrued is \$51.47.


24 Having reviewed the Disbursement Declaration, and good cause appearing,

25 **THE COURT HEREBY ORDERS, ADJUDGES, AND DECREES AS FOLLOWS:**

26 1. The distribution of the funds associated with uncashed Individual Settlement Payment  
27 checks, in an amount of \$22,279.50, and the accrued interest, in the amount of \$51.47, to Legal Aid  
28 at Work is approved.

1           2.       After entry of this Amendment to Final Approval Order and Judgment, pursuant to  
2 California Code of Civil Procedure, Plaintiff shall submit the Amendment to Final Approval Order  
3 and Judgment to the Judicial Council.
