IT IS ORDERED that Plaintiffs' Motion for Final Approval is GRANTED.

- 1. The Court hereby confirms certification of the following Class for settlement purposes only: "All persons classified as 'casual employees' who worked as couriers for DHL Express (USA), Inc. in the State of California from April 10, 2016 through February 3, 2022."
- 2. The dissemination of the Class Notice in the form and manner ordered by this Court was accomplished as directed, and met the requirements of due process.
 - 3. The Court finds that the Class Settlement is fair, reasonable and adequate.
 - 4. The parties are directed to implement the terms of the Settlement Agreement.
- 5. Defendant and the Released Parties as defined in the Settlement Agreement are released and discharged from any and all liability with respect to the Released Claims, as defined in the Settlement Agreement.
- 6. The releases set forth in the Settlement Agreement are approved as to the Settlement Class Members and the Class Representatives. The Class Members and Class Representatives are precluded from instituting, commencing, or continuing to prosecute, directly or indirectly, as individuals or collectively, any action against any of the Released Parties that asserts any Released Claims.
- 7. Final judgment of dismissal is hereby entered, with this Court preserving continuing and exclusive jurisdiction over all matters related to the administration and consummation of the terms of the Settlement and enforcement of the Judgment.
- 8. Within twenty-one (21) calendar days after the Final Effective Date of the Settlement (if no appeal of this Order is filed, then the Final Effective Date will be sixty calendar days following the date of this Order), Defendant shall deposit money into an account, through the Settlement Administrator, the amount of \$1,200,000, plus Defendant's portion of payroll taxes in connection with the wages portion of the Net Settlement Amount, and the amount owed to the Settlement Administrator.
