1. I am a Janney and Janney Court Services employee in the Courts Services Department.


2. The facts set forth herein are known to me personally, and if called as a witness I would and could competently testify thereto.

3. On January 25, 2019 at approximately 10:00 a.m. I received a call from a client, Brianna Juarez at Bleau Fox, a P.L.C., stating that there was an issue with the electronic filing portal on our court services website. This issue was in relation to a single case, SPEEDY FUEL INC. v. GILBARCO, INC.; et al, Case # BC648304.

4. After looking into the case and our court services electronic filing system, I have determined that because there are now well over 2000 case participants involved in this case, our system is not able to support the uploading of documents into this case. After various attempts, the electronic filing system continuously fails to load and eventually times out, thus making it impossible to upload and electronically file any documents in this case.

5. After careful consideration, it is my recommendation that this case be exempt from mandatory electronic filing.
