- 1. I am a Janney and Janney Court Services employee in the Courts Services Department.
- 2. The facts set forth herein are known to me personally, and if called as a witness I would and could competently testify thereto.
- 3. On January 25, 2019 at approximately 10:00 a.m. I received a call from a client, Brianna Juarez at Bleau Fox, a P.L.C., stating that there was an issue with the electronic filing portal on our court services website. This issue was in relation to a single case, SPEEDY FUEL INC. v. GILBARCO, INC.; et al, Case # BC648304.
- 4. After looking into the case and our court services electronic filing system, I have determined that because there are now well over 2000 case participants involved in this case, our system is not able to support the uploading of documents into this case.
