JUDGMENT

Judgment in this matter is hereby entered in accordance with the Court's July 8, 2021 Order Granting Final Approval of Class, Collective, and Private Attorneys General Act ("PAGA") Representative Action Settlement and Awarding Attorneys' Fees and Costs.

The Class is defined as all current or former employees who, between September 29, 2015 and February 9, 2021, are or were employed as Veterinary Assistants for Defendant in California who have not released their claims for severance payments.

No Class Member requested exclusion.

\$84,827.54 will be payable to Class and PAGA Members from the common fund generated by the settlement if all Class and PAGA Members are paid the amount to which they are entitled pursuant to the judgment in this case.

Plaintiffs and the Class shall take nothing from Defendant through this action except as provided for by the Settlement Agreement and the Final Approval Order.

Pursuant to the Settlement Agreement, Code of Civil Procedure section 664.6, and California Rules of Court, Rule 3.769(h), the Court retains jurisdiction over the above-captioned action and the parties, including all Class Members, to enforce the terms of the Judgment for the purposes set forth in the Final Approval Order.

Notice of entry of this Judgment shall be provided to the Settlement Class by posting the Final Approval Order and this Judgment on the settlement website that has been maintained for this action for a period of at least 60 days from entry of judgment.

This Judgment is a final disposition of the above-captioned action in its entirety.

This document shall constitute a judgment for the purposes of California Rules of Court, Rule 3.769(h).
