1 **[PROPOSED] JUDGMENT**

2 Pursuant to the order granting final approval of class action settlement entered on
3 Apr. 6, 2021, IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS
4 FOLLOWS:

5 1. The terms of the settlement reached by Plaintiffs and Defendant, as set forth in
6 the Settlement Agreement, are hereby preliminarily approved as being fair, reasonable and
7 adequate to the members of the Settlement Class, subject to further consideration at the final
8 approval hearing after the distribution of the notice to the members of the Settlement Class as
9 provided in paragraph 6 of this Order.

10 2. The following settlement class is preliminarily approved for settlement purposes
11 only, and is referred to herein as the "Settlement Class": any and all individuals employed as
12 non-exempt food service workers or similar positions in by Defendant, MY WORLD
13 ENTERPRISES, INC., dba ALONDRA HOT WINGS, in the State of California at any time
14 between December 16, 2014 through August 22, 2019;

15 3. This Settlement Agreement (attached hereto as Exhibit 1) releases Defendant MY
16 WORLD ENTERPRISES, INC., dba ALONDRA HOT WINGS, as well as the Released Parties,
17 as defined in paragraph 31 of the Settlement Agreement from any and all Released Claims as
18 defined in paragraph 30 of the Settlement Agreement and below.

19 4. Judgment is entered pursuant to: (1) the terms of the Settlement Agreement; (2)
20 the October 1, 2020, order granting preliminary approval of the Settlement Agreement; and (3)
21 the Apr. 6, 2021 order granting final approval of the Settlement Agreement.

22 5. Neither this final judgment nor the Settlement Agreement shall constitute an
23 admission by Defendant of any liability or wrongdoing, nor is this final judgment a finding of the
24 validity of any of the claims alleged in the lawsuit or a finding of liability or wrongdoing by
25 Defendant.


26 6. Without affecting the finality of the judgment in any way, the Court shall retain
27 exclusive and continuing jurisdiction over the above-captioned action, including the Parties and
28 all Participating Class Members, pursuant to California Rule of Court, rule 3.769, for purposes of

1 supervising, administering, implementing, enforcing, and interpreting the Settlement Agreement,
2 the final approval order, and this judgment.

3 7. In the event that the Effective Date of the Settlement does not occur, this Judgment
4 shall be rendered null and void and any class certified for settlement purposes will be vacated and
5 any other order entered by the Court in furtherance of the Settlement Agreement shall be treated
6 as void *ab initio*. In such an event, the Parties shall return to the status quo as if the Parties had
7 not entered into this Settlement Agreement, as provided in the Settlement Agreement.
