1 The above-entitled action (“Action”) was commenced on January 31, 2018, when Plaintiff  
2 Kerri van Auken (“Plaintiff”) filed a Class Action Complaint for Damages. On May 10, 2018,  
3 Plaintiff filed a First Amended Class Action Complaint for Damages.

4 On December 10, 2020, the Court entered the Final Approval Order and Judgment, thereby  
5 granting final approval of the settlement of the Action reached by Plaintiff and Defendant Hulu, LLC  
6 (“Defendant”) in accordance with Class Action Settlement and Release (collectively, “Settlement,”  
7 “Agreement,” or “Settlement Agreement”), which, together with the exhibits annexed thereto, set  
8 forth the terms and conditions for settlement of the Action.

9 On October 28, 2021, the Declaration of Kevin Lee Regarding Final Accounting (“Final  
10 Accounting Declaration”) was submitted for filing in the Action.

11 On March 11, 2021, the Settlement Administrator issued Individual Settlement Payment  
12 checks to one hundred seventeen (117) Settlement Class Members. Based on the Final Accounting  
13 Declaration, the deadline for Settlement Class Members to cash or negotiate their Settlement Payment  
14 checks expired on September 7, 2021, which is one hundred and eighty (180) calendar days from the  
15 date Individual Settlement Payment checks were issued. As of the date of the Final Accounting  
16 Declaration, there are twenty-nine (29) Individual Settlement Payment checks that were issued on  
17 March 11, 2021, totaling \$31,345.90, that have not been cashed.

18 Pursuant to the Settlement Agreement, the value of any checks uncashed more than one  
19 hundred eighty (180) calendar days after issuance shall be distributed to the California State  
20 Controller’s Office – Unclaimed Property Fund in the name of the Settlement Class Member to whom  
21 payment was issued.

22 Having reviewed the Final Accounting Declaration, and good cause appearing,

23 **THE COURT HEREBY ORDERS, ADJUDGES, AND DECREES AS FOLLOWS:**

24 1. The distribution of the funds associated with uncashed Individual Settlement Payment  
25 checks to the California State Controller’s Office – Unclaimed Property Fund is approved.
