[PROPOSED] ORDER GRANTING PRELIMINARY APPROVAL OF CLASS ACTION AND PRIVATE ATTORNEYS GENERAL ACT SETTLEMENT

Complaint Filed: July 31, 2019

Plaintiff's Motion for Preliminary Approval of Class Action and Private Attorneys General Act Settlement came before this Court on November 29, 2021. The Court having considered the papers submitted in support of the application of the Parties, HEREBY ORDERS THE FOLLOWING:

- 1. The Court grants preliminary approval of the Settlement and the Settlement Class based upon the terms set forth in the Amended Stipulation of Class Action and PAGA Settlement ("Settlement"). All terms used herein shall have the same meaning as defined in the Settlement. The Settlement appears to be fair, adequate, and reasonable to the Class.
- 2. The Settlement falls within the range of reasonableness and appears to be presumptively valid, subject only to any objections that may be raised at the final fairness hearing and final approval by this Court.
- 3. A final fairness hearing on the question of whether the proposed settlement, attorney's fees and costs of Class Counsel, and the Class Representative's Enhancement Award should be finally approved as fair, adequate, and reasonable as to the members of the Class and the PAGA Representative Group is scheduled in Department 21 on the date and time set forth in the implementation schedule in Paragraph 9 below.
- 4. This Court approves, as to form and content, the Notice of Pendency of Class Action and Proposed Settlement ("Notice") in substantially the form attached as Exhibit A to Exhibit "1" ("Settlement") to the Declaration of Kiley Grombacher and also approves the procedure for Class Members to opt out of and object to the Settlement as set forth in the Settlement.
- 5. The Court directs the mailing of the Notice in accordance with the implementation schedule set forth in the Settlement and finds the dates selected for the mailing and distribution of the Notice as set forth therein meet the requirements of due process and provide the best notice practicable under the circumstances and shall constitute due and sufficient notice to all persons entitled thereto.
- 6. It is ordered that the Settlement Class is preliminarily certified for settlement purposes only.
- 7. The court approves Mireya Macias as Class Representative, and Bradley/Grombacher LLP as Class Counsel for the Settlement Class.

- 8. The Court confirms Phoenix Settlement Administrators as the Settlement Administrator.
- 9. The Court orders the following Implementation Schedule for further proceedings:
