The *Motion for Preliminary Approval of Class Action Settlement* brought by plaintiffs Robert Gonzalez, Victor Penate, Blake Bixel, and Mikail Odubona, on behalf of themselves, others similarly situated, and other aggrieved workers (collectively, **Plaintiffs**) is **GRANTED**.

The class consists of roughly 500 members and is defined as follows:

'Class' means all current and former independent contractors and hourly non-exempt employees who performed work for Defendants in California at any time during the Class Period, including: (1) all members of the Class who performed work for Speedy Weedy La Mesa LLC, Speedy Weedy Santa Ana, LLC, Speedy Weedy Vista, LLC, and Welcome The Healing Touch, Inc. as independent contractors at any time from September 4, 2016 through June 1, 2022; (2) all members of the Class who performed work for Speedy Weedy La Mesa LLC, Speedy Weedy Santa Ana, LLC, Speedy Weedy Vista, LLC, and Welcome The Healing Touch, Inc. as non-exempt employees at any time from September 4, 2016 through June 1, 2022. (ROA 43, p. 2:16-23.)

The Court preliminarily approves the following distribution:

- --\$ 464,455.00 amount to be distributed to Class Member (estimated)
- --\$ 259,215.00 attorney fees (estimated) (upper limit is 33.33% of total award)
- --\$ 35,000.00 enhancement award to lead plaintiffs, broken down as follows:

\$15,000.00 – to plaintiff Robert Gonzalez

\$10,000.00 - to plaintiff Victor Penate

\$5,000.00 – to plaintiff Blake Bixel

\$5,000.00 – to plaintiff Mikail Odubona

- --\$ 30,000.00 costs of litigation (estimated) (upper limit)
- --\$ 15,000.00 PAGA payment to LWDA
- --\$ 9,750.00 cost of settlement administration (estimated) (upper limit)
- --\$ 777,645.00 total payment by Defendants
